

Overseas Membership of FLIP Consortium

■ Aim and Activities of the FLIP Consortium

The aim of the FLIP Consortium is to promote academic and engineering science through research and development on upgrading and the advanced use of the computer programs “Finite Element Analysis Program of Liquefaction Process/Response Of Soil-Structure Systems during Earthquakes” (“the FLIP ROSE® Program”) and “Finite Element Analysis Program of Liquefaction Process/Total and Updated Lagrangian Analysis Program of Liquefaction Process” (“the FLIP TULIP® Program”), thereby advancing the state-of-practice in evaluating seismic performance of social infrastructures.

The FLIP Consortium will be engaged in the following activities worldwide:

- (1) Research and development on upgrading FLIP ROSE®, FLIP TULIP® and associated programs (collectively called “FLIP”) and promoting advanced applications thereof;
- (2) Providing FLIP and related manuals, allowing the use of FLIP within the FLIP Consortium, hosting workshops on the use of FLIP, working groups for advanced application on FLIP, and offering general technical support on the use of FLIP;
- (3) Performing analysis and investigation using FLIP; and
- (4) Other activities for achieving the aim of the FLIP Consortium.

■ Overseas Membership

The Overseas Member shall be Overseas Juridical Person or Individual in Overseas as defined by Article 6 of the Articles of Incorporation of the FLIP Consortium who endorses the aim of the FLIP Consortium. Overseas subsidiary, branch or office of Juridical Person in Japan or subsidiary, branch or office in Japan of Overseas Juridical Person are included in Overseas Juridical Person.

The approval of the president or the director in charge of admission of Overseas Members is required for admission to Overseas Membership.

■ Rights of Overseas Member

The Overseas Member is entitled to receive the following FLIP Member Service;

- ◆ Receive **FLIP in the load module** (the programs updated or enhanced by the one other than the FLIP Consortium or the programs which are not approved by the FLIP Consortium are not included in “FLIP”), manuals, Protection Key and related documentation. **One set (10 licenses)** of FLIP programs either in Japanese or in English will be provided. (FLIPGEN in English version is not compatible with FLIPGEN in Japanese version);
- ◆ Receive a limited, non-exclusive, non-transferable right to use FLIP within the geographical area as defined by Item 5 of Article 2 of “Overseas Membership Terms and Conditions” and the entity or individual having the Overseas Membership;
- ◆ Receive general technical support service (Q&A Service) on FLIP; and
- ◆ Participate in events of the FLIP Consortium, including workshop, seminars and Working Groups for advanced applications on FLIP in Japan (only provided in Japanese)

■ Admission Fee and Annual Membership Dues

Admission Fee, Annual Membership Dues and other fees shall be as follows;

Admission Fee*	2,000,000 JPY
Annual Membership Dues	300,000 JPY

***Discount on Admission Fee is available for those who purchased FLIP ROSE ver.7 Series (excluding Academic Discount Version):**

If you purchased FLIP ROSE ver.7 Series	Admission Fee
- Stand Alone Version (excluding Academic Discount Version)	1,000,000 JPY
- LAN-Compatible Version**	500,000 JPY

** If you already purchased FLIP ROSE ver.7 Series at the discount price which is applied to the purchaser of FLIP ROSE ver. 7 Series LAN-Compatible Version, the Admission Fee is 1,000,000JPY.

◆ Readmission to Overseas Membership ◆

Application for readmission to Overseas Membership is allowed only for voluntary withdrawal from membership defined by (1) of Article 14 of Overseas Membership Terms and Conditions (the "Terms and Conditions"). If you lost your membership due to the reason written in (2) or (3) of Article 14 of the Terms and Conditions, readmission to membership will be denied. The readmission requirements are the same as "Overseas Membership" in P1.

Readmission Fee	1,000,000 JPY
Annual Membership Dues	300,000 JPY

NOTE:

- (1) All import duties, taxes, withholding taxes, value added taxes, consumption taxes, charges and other additional costs (collectively, "Other Costs") are NOT included in the Admission Fee, Readmission Fee and Annual Membership Dues;
- (2) The Admission Fee, Readmission Fee and Other Costs paid to the FLIP Consortium are non-refundable except for cancellation by an individual applicant within the period specified in Article 5 of the Terms and Conditions;
- (3) The fiscal year of the FLIP Consortium is from July 1 through June 30 of the following year ("Fiscal Year"). When an application is made after July 1 for a certain Fiscal Year, the Annual Membership Dues are 300,000 JPY and will be effective only to the end of such Fiscal Year;
- (4) If you register in FLIP ROSE ver.7 Series Support Service Agreement and already paid the Support Service Fee, the amount equivalent to the amount already paid by you for the said Support Contract Term will be deducted from the Annual Membership Dues.
- (5) The Annual Membership Dues cover the cost of Q&A Service for one person; and
- (6) The Overseas Member shall bear all Other Costs incurred in admission or readmission to or maintenance of its membership. The Overseas Member located outside Japan shall also bear all charges for shipping and handling during admission or readmission procedures.

*All Other Costs are **NOT** included in these fees.
